Please read carefully!

By accessing this site, you accept these policies.

This web site (the "Site") is provided and maintained by the Grand Junction Regional Airport ("the Airport"). This web site serves as a service to distribute information about the Airport. The Site is provided "as is" and with all faults. The Airport makes no representations or warranties of any kind, express or implied.

The Airport reserves the right to update the Privacy Policy (the "Policy") at any time. Updates will be posted here and effective upon posting. You agree to check for updates to the Policy regularly.

The Airport is committed to protecting your privacy. The Airport will not collect any personal information from you that you do not volunteer. The Airport is the sole owner of all information collected on this site. The Airport will not sell, share, or rent this information to others in any way that has not been mentioned in the Policy.

Obtaining your Consent

By using the Site, you give the Airport permission to collect information about the pages served to you as an anonymous user for the purpose of calculating aggregate site statistics and to enhance the relevancy of the Site. If you register at the Site, you authorize the Airport to use information you provide to personalize the information we deliver to you and to use your demographic information when calculating aggregate customer data.

E-mail addresses and other personally identifying data about each user is known to the Airport only when voluntarily submitted or emailed by a user. Providers use personally identifying data to inform about products, offers, events and other information which the user indicates are of interest, or which the Airport feel may be of interest to you.

If you no longer wish to receive e-mail communications from the Airport, you should follow the removal instructions located at the bottom of the e-mail received.

Cookies

Cookies are used to identify registered users and to provide the personalization preferences indicated previously by the user. The cookies allow the Site to track movement within the Site and provides no information on activity outside of the Site. Removal or disabling of the cookie will not allow the Site to recognize the user.

Cookies may also be used to track usage of the Site by non-registered users. These cookies do not provide any personal identification and are only used to further the Airport's understanding of how users navigate and use the Site. This information is used to optimize the Site and increase usability for all users.

Third Parties

The Airport may provide third parties with aggregate statistics about users, traffic patterns, and related site information. This data reflects usage patterns gathered during thousands of user visits to the Site each month but does not contain behavioral or identifying information about any individual user, unless that user has given the Airport permission to share that information. The Airport may also provide log files and other databases of user information to third parties for analysis, to gain a better understanding of traffic through the Site and thus improve content offerings. The Airport also may use third party companies to provide delivery of e-mail newsletters and other messages over e-mail.

Submitted Materials

The Airport welcomes user comments and suggestions regarding the Site. Note, however, that any notes, messages, postings, ideas, suggestions, or other material, submitted to the Airport, becomes property of the Providers and may be used, not used, or modified by the Airport at their sole discretion.
